- Approximate budget needed with break up of at least 5 items
- Possible impact and relevance
- Include a statement that this is your original idea that you intend to pursue in the near future. If a post graduate student is applying, the project **must not** be the thesis or dissertation. This must be endorsed by the Guide and HOD.
- Minimum 1500 words and not to exceed 2,000 words.

C . A Personal Statement

- **On what** Interested you to apply for this course, what research have you already been involved in (brief description) how this course will benefit your long term goals, how you hope to achieve it and why you deserve this award.
- **Do include a statement that funds are not available from your Institution for such training**
- Minimum 750 words and not to exceed 1500 words.
